DATE OF FINAL PASSAGE JUL 12 2021

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF A MASTER SERVICES AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND CGI TECHNOLOGIES AND SOLUTIONS, INC. FOR APPLICATION, DEVELOPMENT, MAINTENANCE AND SUPPORT FOR MANAGED IT SERVICES.

WHEREAS, on December 19, 2019, the City issued a Request for Proposal (RFP) for Managed IT Services, RFP #10089620-21-K, which allowed proposers to submit bids for up to three towers of services: Application Development, Maintenance and Support (ADMS), Enterprise Compute and Workplace; and

WHEREAS, after a comprehensive review of the proposals, the City selected CGI Technologies and Solutions, Inc. (CGI) for the ADMS tower of services as the best overall value to the City; and

WHEREAS, this item seeks authorization for the Mayor or his designee to execute a Master Services Agreement for ADMS services with CGI (Agreement) with a transition period of approximately twelve (12) months plus a four-year Initial Term, two (2) two-year option periods, and a disentanglement period of up to twenty-four (24) months, in an amount not-to-exceed \$84,162,764 during the full term of the Agreement, including option years and any disentanglement period; and

WHEREAS, under San Diego City Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by ordinance approved by a two thirds' majority vote of the Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, a Master Services Agreement between the City of San Diego and CGI Technologies and Solutions, Inc. for Application, Development, Maintenance and Support for Managed IT Services, with a not-to-exceed amount of \$84,162,764, for a term that includes a transition period of approximately twelve (12) months, plus a four year Initial Term, two (2) two-year option periods, and a disentanglement period of up to twenty-four (24) months, under the terms and conditions contained in the Agreement on file with the City Clerk as Document No. OO-21341.

Section 2. That the Chief Financial Officer is hereby authorized to expend an amount not to exceed \$84,162,764 over the term of the Agreement, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
