DATE OF FINAL PASSAGE JAN 12 2021

A RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO CONFIRMING APPOINTMENTS TO THE
SAN DIEGO UNIFIED PORT DISTRICT BOARD OF
COMMISSIONERS.

WHEREAS, the Council of the City of San Diego has the power to appoint commissioners to the San Diego Unified Port District Board of Commissioners under the San Diego Port Act; and

WHEREAS, appointments to boards and commissions are governed procedurally by Council Policy No. 000-13; and

WHEREAS, said policy permits recommendations of nominees by Councilmembers for appointments to those boards and commissions which the Council has the power of appointment; and

WHEREAS, the following nominations have been made:

(1) Commissioner Rafael Castellanos has been nominated for reappointment by Councilmember Joe LaCava, Councilmember Raul A. Campillo, Councilmember Vivian Moreno, and Councilmember Sean Elo-Rivera;

(2) Commissioner Nominee Lisa Harris has been nominated for appointment by Council President Pro Tem Stephen Whitburn and Councilmember Monica Montgomery Steppe;

(3) Commissioner Nominee Jennifer LeSar has been nominated for appointment by Council President Pro Tem Stephen Whitburn and Councilmember Joe LaCava; and

WHEREAS, the nominees were considered under the Council Policy 000-13 procedure by the Council at its meeting of January 12, 2021; and

WHEREAS, the appointment of Port Commissioners is in the sole discretion of the Council under the Port Act and is therefore not subject to veto; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Rafael Castellanos and Jennifer LeSar are appointed to the San Diego Unified Port District Board of Commissioners for a term ending January 2, 2025.


