A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION AND FUNDING OF OPTION YEARS IN THE CONSULTANT SERVICES CONTRACT BETWEEN THE CITY OF SAN DIEGO AND SQUIRE PATTON BOGGS (US), LLP, TO PROVIDE FEDERAL LEGISLATIVE AND EXECUTIVE BRANCH CONSULTING SERVICES AND REPRESENTATION.

WHEREAS, by San Diego Resolution R-312169 (Jan. 11, 2019), the San Diego City Council (Council) authorized the Mayor or his designee to execute a contract between the City of San Diego (City) and Squire Patton Boggs (US), LLP, for Federal Legislative and Executive Consulting Services and Representation, under the terms and conditions of the contract, which is on file in the Office of the City Clerk as Document Number RR-312169 (Contract); and

WHEREAS, the Contract is for a three-year period, with two one-year options to renew, and it was signed by the Director of the City's Purchasing and Contracting Department and took effect on January 1, 2019; and

WHEREAS, the Contract was awarded through a competitive process in accordance with the City's Municipal Code, including sections 22.3202 and 22.3207; and

WHEREAS, the Contract, at Article III, section 3.1, sets forth a not-to-exceed amount of \$168,000 per year for five years; and

WHEREAS, in approving the Contract, the Council authorized the Mayor to execute the Contract and the Chief Financial Officer to expend an amount not to exceed \$504,000, which included the condition that funding was contingent upon the adoption of the Fiscal Year 2020

Appropriation Ordinance and the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be on deposit with the City Treasurer; and

WHEREAS, the Mayor, acting through the director of the Government Affairs

Department, now requests that the Council grant the Mayor or his designee discretionary authority to determine whether to extend the Contract for each additional option year, as described in the Contract, and to execute any agreements to extend the Contract; and

WHEREAS, the Mayor, acting through the director of the Government Affairs

Department, also seeks Council authorization to expend an amount not to exceed \$840,000 in payment for services provided under the Contract, which represents the agreed-upon not-to-exceed amount of \$168,000 per year for the full five years; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that:

- The Council grants the Mayor or his designee discretionary authority to execute
 each of the two one-year options to extend the Contract between the City and
 Squire Patton Boggs (US), LLP, which is on file in the Office of the City Clerk as
 Document Number RR-312169.
- 2. The Council authorizes the Chief Financial Officer to expend an amount not to exceed \$168,000 per year for each year of the Contract, if the Contract is in effect, with the total Contract amount not to exceed \$336,000 over the period of the two one-year options, beginning December 1, 2021; this authorization is contingent upon the Council's adoption of the Annual Appropriation Ordinance for each applicable fiscal year and upon the Chief Financial Officer first furnishing a

certificate, stating that funds necessary for the authorized expenditures for services under the Contract are, or will be, on deposit with the City Treasurer.
