A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING THE APPOINTMENT OF JAY GOLDSTONE TO SERVE AS CITY MANAGER (CHIEF OPERATING OFFICER) ON AN INTERIM BASIS AND IN ACCORDANCE WITH SAN DIEGO MUNICIPAL CODE SECTION 24.1001.

WHEREAS, San Diego Charter (Charter) section 265 sets forth the duties of the City of San Diego (City)'s Mayor; and

WHEREAS, Charter section 265(b)(7) states that the Mayor has "[s]ole authority to appoint the City Manager, subject to Council confirmation"; and

WHEREAS, the City Manager is commonly referred to as the City's Chief Operating Officer; and

WHEREAS, the position of Chief Operating Officer has been vacant; and

WHEREAS, Mayor Todd Gloria has appointed Jay Goldstone to serve as the Chief Operating Officer on an interim basis; and

WHEREAS, Mr. Goldstone previously served as the City's Chief Operating Officer from 2008 to 2013, and has the special skills and knowledge to assume this new appointment under the conditions set forth in San Diego Municipal Code section 24.1001; and

WHEREAS, Mayor Gloria has supervisory authority over the Chief Operating Officer, in accordance with Charter section 265(b)(7), and the authority to set the compensation for the Chief Operating Officer, in accordance with Charter sections 28 and 70, so long as the compensation is within the compensation rates for the position as established by the City Council in adopting the annual Salary Ordinance and is consistent with San Diego Municipal Code section 24.1001; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council confirms the appointment of Jay Goldstone to service in the position of City Manager, which is also known as Chief Operating Officer, on an interim basis and in accordance with the Charter and San Diego Municipal Code section 24.1001, with the appointment to take effect upon the date of final passage of this Resolution.
