A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING THE APPOINTMENT OF
MATTHEW VESPI AS THE CITY'S CHIEF
FINANCIAL OFFICER IN ACCORDANCE WITH SAN
DIEGO CHARTER SECTION 39.

WHEREAS, San Diego Charter (Charter) section 39 provides that the Chief Financial Officer of the City of San Diego (City) is appointed by the Mayor and confirmed by the City Council (Council) for an indefinite term; and

WHEREAS, Charter section 39 further provides that the Chief Financial Officer is the City's chief fiscal officer, who is responsible for supervising all accounts showing financial transactions of the City; and

WHEREAS, the Chief Financial Officer is also responsible for preparing the City's annual budget, subject to the direction and supervision of the Mayor, and for overseeing the City's financial management, treasury, risk management, and debt management functions; and

WHEREAS, the Chief Financial Officer serves until his or her successor is appointed and qualified; and

WHEREAS, Mayor Todd Gloria has appointed Matthew Vespi to serve as the City's Chief Financial Officer, succeeding Rolando Charvel, and now presents this appointment to the Council for confirmation; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that, in accordance with Charter section 39, the Council confirms the Mayor's appointment of Matthew Vespi to serve as the City's Chief Financial Officer, with his appointment taking effective upon the date of final passage of this Resolution.
