Comprehensive Annual Financial Report (CAFR), together with an unmodified opinion of the City's independent auditor, Macias, Gini & O'Connell LLP (Macias), dated December 21, 2020, relative to the City's fiscal year 2020 financial statements and such documents are on file in the Office of the City Clerk as Document No. Re. 313429; and

WHEREAS, the CAFR is the responsibility of the City management and the role of the Council, as part of its legislative oversight responsibilities, is to determine, to each Council member's satisfaction, based on the process followed, including the certifications of certain City officials regarding the CAFR, and applying the knowledge that each Council member has of the City's affairs, that there is no reason the CAFR should not be made available to investors and the securities markets as an official document of the City; and

WHEREAS, while the Council is not required to review the City's CAFRs this Council deems it prudent and a best practice for the Council to do so to ensure that appropriate and reasonable processes have been followed in the preparation of CAFRs since they contain the City's financial statements and other information that will be included in official statements and other disclosure documents used in connection with sale of securities of the City and its related entities; and

WHEREAS, in accordance with the San Diego Municipal Code sections 22.4108(a)(1) and 22.4111 and the Disclosure Controls and Procedures adopted by the Disclosure Practices

Working Group (DPWG), DPWG reviewed the draft of the Fiscal Year 2020 CAFR (FY 2020 CAFR) presented to the DPWG on September 30, 2020, including approved revisions incorporated into the FY 2020 CAFR at subsequent meetings through December 3, 2020, and in the best judgment of DPWG, such draft was in substantially final form, subject to the receipt of the final opinion letter of Macias and the certification of the Chief Financial Officer, and the certifications of the Chief Financial Officer and DPWG are on file in the Office of the City Clerk as Document No. 313429 and Document No. 313429, respectively; and

WHEREAS, on January 27, 2021, the Audit Committee reviewed the FY 2020 CAFR in accordance with its procedures and recommended that the Council receive and file the FY 2020 CAFR; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the City's FY 2020 CAFR is hereby received by and filed with the City Council.
