A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AMENDING COUNCIL POLICY 200-01,  
ENTITLED "DISTRIBUTION OF STREET IMPROVEMENT  
COSTS."

WHEREAS, in 1956, the City Council adopted Council Policy 200-01 establishing the distribution of costs for street improvements based upon the type of street and the benefit provided by the street to abutting property owners, the community and the City; and

WHEREAS, Council Policy 200-01 was last amended in 1979 and additional amendment was needed to clarify the policy and delete references to another repealed Council Policy; and

WHEREAS, some streets and alleys are part of the City's street system, but were built before the City established standards for its streets, and therefore due to their unimproved state are not included in the City's street resurfacing maintenance program; and

WHEREAS, in the interest of seeking consistency in the level of service provided to residents, Council Policy 200-01 is amended such that Unimproved Streets and Unimproved Alleys may be eligible to receive City funded improvements contingent upon the availability of funding, subject to the processes for evaluating Capital Improvement Projects as set forth in Council Policy 800-14, and subject to other contingencies as set forth in the amended Council Policy 200-01; and


WHEREAS, funding for improvements to Unimproved Streets and Unimproved Alleys shall be determined during the City's annual budget process for Capital Improvement Projects as set forth in Council Policy 800-14; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That Council Policy 200-01 is amended as set forth in the Council Policy on file with the City Clerk as Document No. RR- 313435.

2. That the City Council directs the City Clerk to update the Council Policy Manual to reflect the amended Council Policy 200-01.
