A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING THE RECOMMENDATION THAT NO MID-YEAR REVISIONS BE MADE TO THE FISCAL YEAR 2021 BUDGET OF THE CITY OF SAN DIEGO.

WHEREAS, on June 9, 2020, the Mayor approved Resolution No. R-313071, approving the City's Fiscal Year 2021 Budget (2021 Budget); and

WHEREAS, on June 30, 2020, the City Council adopted Ordinance No. O-21206, entitled "An Ordinance Adopting the Annual Budget for Fiscal Year 2021 and Appropriating the Necessary Money to Operate the City of San Diego for Fiscal Year 2021." (Appropriation Ordinance); and

WHEREAS, on December 15, 2020, the Department of Finance presented to City Council its Fiscal Year 2021 First Quarter Budget Monitoring Report (First Quarter Report); and

WHEREAS, on January 25, 2021, the Fiscal Year 2021 Mid-Year Budget Monitoring Report, (Mid-Year Report) was issued; and

WHEREAS, the Mid-Year Report projects a deficit of approximately \$85.4 million relative to the 2021 Budget as adopted by the Appropriation Ordinance; and

WHEREAS, the Mayor has recommended that no modifications be made to the 2021 Budget in the Mid-Year Report due in part to the expectation that the City will likely receive Federal stimulus related to the ongoing COVID-19 pandemic before the end of the fiscal year; and

WHEREAS, the City Council desires to approve the recommendation that no changes be made at this time to the 2021 Budget as provided in the Mid-Year Report; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the recommendation that no changes be made at this time to the 2021 Budget as provided in the Mid-Year Report is accepted.
