A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING COUNCILMEMBER
APPOINTMENTS TO THE TEMPORARY SPECIAL ISSUES
COMMITTEE NAMED THE COMMITTEE ON COVID-19
RESPONSE AND RECOVERY.

WHEREAS, temporary Rule 6.11.3 of the Rules of the Council in the San Diego
Municipal Code, approved by the Council of the City of San Diego (Council), has established the
temporary Special Issues Committee named the Committee on COVID-19 Response and
Recovery (Committee); and

WHEREAS, temporary Rule 6.11.3 provides that the Council President shall nominate
two Committee co-chairs and committee members, subject to confirmation by a majority vote of
the Council; and

WHEREAS, Council President Jennifer Campbell has submitted nominations for those
who are to serve on the Committee for one year, which may be renewed if the Council extends
the committee's work, or until successors are named and confirmed; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to
veto by the Mayor because this matter is exclusively within the purview of the Council and not
affecting the administrative service of the City under the control of the Mayor; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to the San Diego Municipal Code, the following appointments by the Council President, to serve as co-chairs and Committee members of the temporary Special Issues Committee named the Committee on COVID-19 Response and Recovery, to serve for one year, which may be renewed if the Council extends the Committee's work, or until a successor is duly nominated and confirmed, are hereby confirmed: Council President Jennifer Campbell (Co-Chair), Councilmember Marni von Wilpert (Co-Chair), Council President Pro Tem Stephen Whitburn and Councilmember Sean Elo-Rivera.
