A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986 APPROVING THE ISSUANCE OF BONDS BY THE HOUSING AUTHORITY OF THE CITY OF SAN DIEGO FOR GRANT HEIGHTS II APARTMENTS.

WHEREAS, the Housing Authority of the City of San Diego (Authority) intends to issue not to exceed \$8,965,000 principal amount of multifamily housing revenue bonds (Bonds) to finance costs of the acquisition and rehabilitation of multifamily affordable housing facilities collectively identified as Grant Heights II Apartments in the City of San Diego (City) described in the Notice of Public Hearing attached as Exhibit A hereto (Project); and

WHEREAS, the Bonds are expected to be issued in two series, and it is expected that the interest on one of the series of the Bonds to be issued in an aggregate principal amount not to exceed \$8,815,000 (Tax-Exempt Bond), will be excludable from the gross income of the owner of the Tax-Exempt Bond for purposes of federal income taxation; and

WHEREAS, in order for interest on the Tax-Exempt Bond to be tax-exempt, section 147(f) of the Internal Revenue Code of 1986 (Code) requires that the Tax-Exempt Bond be approved by the City Council as the applicable elected representative after a public hearing following reasonable public notice; and

WHEREAS, the City Council held a public hearing regarding the issuance of the Tax-Exempt Bond and the financing of the Project on October 1, 2019, and following the public hearing the City Council adopted Resolution No. R-312682, with a date of final passage of October 8, 2019, approving the issuance of the Tax-Exempt Bond by the Authority; and

WHEREAS, applicable United States Treasury Regulations (Regulations) require that the

City Council's approval of the Tax-Exempt Bond occur within one year of its issuance by the

Authority, and because the Authority will issue the Tax-Exempt Bond more than one year after

the City Council's October 8, 2019 approval of its issuance, the City Council now desires to

again approve the issuance of the Tax-Exempt Bond by the Authority; and

WHEREAS, one or more notice(s) of a public hearing with respect to the proposed

issuance of the Bonds were timely published in accordance with the Regulations; and

WHEREAS, the new public hearing regarding the financing of the Project and the

issuance by the Authority of the Bond was held by the City Council on February 22, 2021, and

an opportunity was provided for interested persons to express their views on the issuance of the

Bonds and on the nature and location of the Project; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego that this City Council,

as the applicable elected representative under section 147(f) of the Code, approves the issuance

by the Authority of the Bonds, including the issuance of the Tax-Exempt Bond.

BE IT FURTHER RESOLVED, that the City does not warrant the creditworthiness of the

Bonds or guarantee, in any way, the payment of the Bonds. No moneys of the City will be

pledged or applied to the repayment of the Bonds.

The owner of the Projects is expected to be Grant Heights II, L.P., a California limited partnership. The manager of the facilities when they have been completed will be ConAm Management Corporation or another entity selected by the owner of the Projects. Forty-one of the units in the Projects are expected to be income and rent restricted and will be occupied by low or very low-income tenants at affordable rents.

It is expected that the interest on up to \$8,815,000 principal amount of the Bonds will be excludable from the gross income of the owner of such portion of the Bonds for purposes of federal income taxes.
