A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING A COOPERATIVE
PROCUREMENT CONTRACT WITH HAWTHORNE
EQUIPMENT CO (DBA HAWTHORNE CAT) TO PURCHASE
HEAVY CONSTRUCTION EQUIPMENT, RELATED
ACCESSORIES, ATTACHMENTS AND SUPPLIES.

WHEREAS, Fleet Operations provides, maintains, and repairs a fleet of over 4,500 vehicles and equipment for the various City Departments; and

WHEREAS, Fleet Operations has identified 78 pieces of heavy construction equipment that are reaching the end of their lifecycle and will require replacement over the next several years with an estimated contract value of \$15,500,000.

WHEREAS, Caterpillar Inc was awarded a contract after a request for proposals for the procurement of Heavy Construction Equipment with Related Accessories, Attachments, and Supplies by a public agency; and

WHEREAS, Fleet Operations wishes to enter into a contract with Hawthorne Equipment Co. (dba Hawthorne CAT), the authorized dealership of Caterpillar Inc, to meet the City's needs for providing cost-effective, efficient and reliable heavy construction equipment to various City Departments; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute a contract with Hawthorne Equipment Co. (dba Hawthorne CAT) to purchase heavy construction equipment, related accessories, attachments and supplies for the City's fleet as required, in an amount not to exceed \$15,500,000, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$15,500,000 from the applicable Fleet Replacement Funds (720002-720037 and 720058-720059), over the contract term ending May 13, 2023, and for an optional one year extension, to purchase heavy construction equipment, related accessories, attachments and supplies, contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
