WHEREAS, the Housing Authority of the City of San Diego (Authority), from time to time issues multifamily housing revenue bonds (Bonds) to finance the acquisition, construction, and/or rehabilitation of multifamily affordable housing projects (Projects) in the City of San Diego (City); and

WHEREAS, in order for interest on the Bonds to be tax-exempt, section 147(f) of the Internal Revenue Code of 1986 (Code) requires that the Bonds be approved by the applicable elected representative of the government unit having jurisdiction over the area where the Projects are located, after a Tax Equity and Fiscal Responsibility Act (TEFRA) public hearing following reasonable public notice; and

WHEREAS, the Code provides that the government unit may select its own procedure for a public hearing, provided that interested individuals have a reasonable opportunity to express their views, and the government unit may appoint an individual to conduct the public hearing on its behalf; and

WHEREAS, the City Council, as the applicable elected representative, desires to appoint the Housing Commission's President and Chief Executive Officer (President & CEO) to conduct the TEFRA public hearings on its behalf; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that this City Council, as the applicable elected representative under section 147(f) of the Code, authorizes the President & CEO to conduct TEFRA public hearings on its behalf.
