# RESOLUTION NUMBER R-313457 DATE OF FINAL PASSAGE MAR 1 1 2021

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986 APPROVING THE ISSUANCE OF BONDS OR NOTES BY THE HOUSING AUTHORITY OF THE CITY OF SAN DIEGO FOR MISSISSIPPI ECB APARTMENTS.

WHEREAS, the Housing Authority of the City of San Diego (Authority) intends to issue not to exceed \$12,150,000 aggregate principal amount of multifamily housing revenue bonds or notes (Bonds) to finance the acquisition, construction and equipping of a multifamily rental housing project in the City of San Diego (City) described in the Notice of Public Hearing attached as Exhibit A hereto (Project); and

WHEREAS, in order for interest on the Bonds to be tax-exempt, section 147(f) of the Internal Revenue Code of 1986 (Code) requires that the Bonds be approved by the City Council as the applicable elected representative after a public hearing following reasonable public notice; and

WHEREAS, applicable guidance from the Internal Revenue Service requires that the opportunity to be heard be provided to the public via telephonic means with a toll free 800 number, and because the Authority originally held a public hearing in June of 2020 permitting access to the public via other means, the City Council now desires to again approve the issuance of the Bonds by the Authority and to conduct a new public hearing; and

WHEREAS, one or more notice(s) of a new public hearing with respect to the proposed issuance of the Bonds were timely published in accordance with said section 147(f); and

WHEREAS, the new public hearing was held on March 9, 2021, and an opportunity was

provided for interested persons to express their views on the issuance of the Bonds and on the

nature and location of the Project; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego that this City Council,

as the applicable elected representative under section 147(f) of the Code, approves a plan of

financing for the issuance of the Bonds (together with a like amount of refunding obligations) by

the Authority.

BE IT FURTHER RESOLVED, that the City does not warrant the creditworthiness of the

Bonds or guarantee, in any way, the payment of the Bonds. No moneys of the City will be pledged

or applied to the repayment of the Bonds.

### **NOTICE OF PUBLIC HEARING**

The owner of the Project is expected to be Trestle Mississippi, LP, a California limited partnership, or another limited partnership to be formed by Rise Urban Partners LLC (Rise). Rise or an affiliate will operate the Project when complete. Sixty (60) of the residential units in the Project are to be income and rent restricted and will be occupied by low or very low-income tenants at affordable rents.
