A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A CONTRACT WITH SUNROAD AUTO, LLC DBA KEARNY MESA FORD-KIA TO PURCHASE FORD ORIGINAL EQUIPMENT MANUFACTURER NEW AND REFURBISHED PARTS AND ACCESSORIES.

WHEREAS, the City of San Diego's Fleet Operations Department operates and maintains a fleet of approximately 4,500 vehicles and equipment to support all City services; and

WHEREAS, the City maintains an estimated fleet of 2,700 Ford vehicles of various types, including law enforcement patrol, pick-ups, sedans, and other support vehicles; and

WHEREAS, the City requires parts and accessories for its broad variety of Ford vehicle lines and technical support; and

WHEREAS, the City issued a Request for Proposal, RFP # 10089716-21-V, on October 13, 2020 to procure Ford Motor Company (Ford) Original Equipment Manufacturer new and refurbished Parts and Accessories and Related Products for Ford light, medium, and heavy-duty trucks, cars, vans, and SUV vehicles and Related Special Program Support; and

WHEREAS, in response to RFP # 10089716-21-V, the City received and evaluated one proposal, submitted by Sunroad Auto, LLC, dba Kearny Mesa Ford-Kia (Sunroad Auto), a local company, and now seeks to award a contract to Sunroad Auto as a qualified contractor, which would provide the best overall value to the City over the five (5) year term of the Contract;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a contract with Sunroad Auto, to purchase Ford Original Equipment Manufacturer new and refurbished parts and accessories for

the City's fleet on an as-needed basis, in an amount not to exceed \$9,671,000 over the five (5) year term of the Contract, pursuant to the terms and conditions set forth in the Contract, on file with the Office of the City Clerk as Document No. RR- 313458 .

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$9,671,000 from Fleet Operations Operating Fund 720000, over the five (5) year term of the Contract, to purchase Ford Original Equipment Manufacturer new and refurbished parts and accessories, contingent upon the approval of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
