A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF THE SECOND AMENDMENT TO THE AGREEMENT WITH INDUSTRIAL/ORGANIZATIONAL SOLUTIONS, INC. FOR THE PROVISION OF CONSULTING SERVICES FOR FIRE-RESCUE PROMOTIONAL EXAMINATIONS.

WHEREAS, on November 14, 2017, the City of San Diego entered into a contract with Industrial/Organizational Solutions, Inc. (I/O Solutions) for the provision of consulting services for Fire-Rescue promotional examinations in the amount of \$83,230; and

WHEREAS, through this contract, I/O Solutions performs a job analysis and develops and administers promotional exams for the Fire Captain and Battalion Chief ranks of the Fire-Rescue Department; and

WHEREAS, the contract with I/O Solutions was amended in 2019 to increase the contract amount by \$166,460 for a total contract amount of \$249,690; and

WHEREAS, the City now seeks approval of a Resolution authorizing the Mayor, or his designee, to execute the Second Amendment with I/O Solutions to increase the contract amount by \$167,746, for a total contract amount of \$417,436; and

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute the Second Amendment to the Contract with Industrial/Organizational Solutions, Inc. for the provision of consulting services for Fire-Rescue promotional examinations, under the terms and conditions set forth in the Second Amendment to the Contract, on file in the Office of the City Clerk as Document No. RR- 313473.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$167,746, for the purposes of executing this Second Amendment, contingent upon the Chief Financial Officer first certifying funds are, or will be, on deposit with the City Treasurer.
