A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE COOPERATION AND
ADMINISTRATIVE SERVICES AGREEMENT WITH
SAN DIEGO COMMUNITY POWER.

WHEREAS, the City Council of the City of San Diego (City) adopted San Diego Resolution R-312666 (Sep. 17, 2019) to enter into a Joint Powers Agreement (JPA Agreement) creating the San Diego Regional Community Choice Energy Authority (SDRCCEA); and

WHEREAS, the City Council of the City of San Diego adopted San Diego Ordinance O-21133 (Oct. 1, 2019) for the implementation of a Community Choice Aggregation Program (CCA); and

WHEREAS, SDRCCCEA has changed its name to San Diego Community Power (SDCP); and

WHEREAS, SDPCP is a CCA Joint Powers Authority established in order to provide its member cities with the opportunity to purchase increased levels of renewable electricity and to provide the businesses and residents of the member cities with that same opportunity; and

WHEREAS, as a member of SDPCP, the City has since 2018 provided (and is providing) support services to SDPCP including staff assistance, supplies, contracted technical services, and other services and facilities in order to assist in establishing the program for the benefit of the City and the other SDPCP member cities; and

WHEREAS, Section 3.2.13 of the of the SDPCP Joint Powers Agreement (JPA Agreement) authorizes SDPCP to enter into an Administrative Services Agreement with the City of San Diego for the provision of administrative and other services to SDPCP; and

WHEREAS, a Cooperation and Administrative Services Agreement will provide that SDCP will compensate the City for its substantial contributions to SDCP; and

WHEREAS, Section 7.3.2 of the JPA Agreement acknowledges that the City has funded and will fund certain activities necessary to implement the CCA Program, and if the CCA Program becomes operational, the costs paid by the City shall be reimbursed from SDCP Revenue subject to the terms of the JPA Agreement; and

WHEREAS, the City and SDCP intend to provide for such reimbursement according to the terms and conditions in the Cooperation and Administrative Services Agreement approved by this Resolution; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the Cooperation and Administrative Services Agreement with San Diego Community Power, under the terms and conditions set forth in the Document, on file in the Office of the City Clerk as Document No.
