A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
ESTATE OF KEVIN BROWN AND REBECCA BROWN AND
CITY OF SAN DIEGO.

WHEREAS, on July 16, 2015, ESTATE OF KEVIN BROWN by its successor in interest
Rebecca Brown, and Rebecca Brown, filed suit against the City of San Diego, and others,
alleging wrongful death and violation of civil rights based on an investigation of decedent Kevin
Brown. Plaintiffs brought suit in the United States District Court, Southern District. The suit is
entitled *Estate of Kevin Brown, et al. v. City of San Diego, et al.*, United States District Court
Case No. 15cv1583 DMS (WVG) [Litigation]; and

WHEREAS, in Closed Session on March 2, 2021, the City Council, by the following
votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays, none, and absent, none, approved the
settlement; and

WHEREAS, the City Council in closed session on March 2, 2021, authorized settlement
of the Litigation for an amount consistent with the amounts set forth below and pursuant to such
other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$5,812,000.00 from
Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest,
costs, and fees of any type, including attorney fees, against City of San Diego, its agents and
employees, arising from the action.

2) Authorize the Chief Financial Officer to expend an amount not to exceed \$5,812,000.00 from Public Liability Fund No. 720045, for the purpose of settling this claim.
