A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
ELLEESA KIMBERLY CHAVEZ AND THE CITY OF SAN
DIEGO ET AL.

WHEREAS, on October 29, 2019, ELLEESA KIMBERLY CHAVEZ filed a lawsuit against CITY OF SAN DIEGO, et al. alleging personal injuries arising out of a motor vehicle accident that occurred on May 6, 2019, entitled *Elleesa Kimberly Chavez v. City of San Diego, et al.*, San Diego Superior Court, Case No. 37-2019-00057225-CU-PA-CTL [Litigation]; and

WHEREAS, in Closed Session on March 9, 2021, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and Absent, None, approved the settlement; and

WHEREAS, the City Council in Closed Session on March 9, 2021, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$16,000,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the Litigation.

2. Authorizes the Department of Finance to expend an amount not to exceed \$16,000,000 from Public Liability Fund No. 720045, for the purpose of settling this claim.
