WHEREAS, the Commission consists of seven members appointed by the Mayor, subject to Council confirmation; and

WHEREAS, members of this Commission serve for four-year terms and until their successors are elected, appointed, and qualified; and

WHEREAS, appointments to the Commission are to be made so that not more than three members are appointed in any one year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment by the Mayor of the City of San Diego, to serve as a member of the Planning Commission, for a term ending as indicated, is made and hereby confirmed:


