A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING FINAL CONTRACT CHANGE ORDER NO. 5 WITH WEST COAST GENERAL CORPORATION IN CONNECTION WITH THE 101 ASH STREET IMPROVEMENT PROJECT.

WHEREAS, the Council of the City of San Diego (City Council) approved a lease-to-own agreement in October 2016 for the 101 Ash Street Building; and

WHEREAS, the lease-to-own agreement was to provide the City with a long-term solution for employee office space occupancy in non-City owned facilities; and

WHEREAS, the City needed to do some tenant improvements in the building to accommodate as many City employees as possible; and

WHEREAS, staff presented a report to the City Council on June 18, 2018, that included four tenant improvement options for how the 101 Ash Street Building could be occupied:

Option 1 – to do no tenant improvements, Option 2 – to do only the first floor, Option 3 – to do five floors of the building, and Option 4 – to do all 19 floors; and

WHEREAS, the City Council authorized staff to go out to bid with Option 3 (five floors of tenant improvements) as the base bid, and to include an additive alternate to do tenant improvements to all 19 floors of the building (Option 4); and

WHEREAS, on August 7, 2018, the bids were brought back to City Council, and at that meeting it was decided to move forward with awarding the base bid plus the additive alternate, to do tenant improvements to all 19 floors; and

WHEREAS, following the City Council's direction, the City entered into construction contract K-18-1586-DBB-3-A with West Coast General Contractors (WCGC) for tenant improvements on all 19 floors at 101 Ash Street (Project) in the amount of \$17,080,261.00; and

WHEREAS, WCGC made claims under their contract to the City for additional compensation due to differing site condition and extra work; and

WHEREAS, construction on the Project began September 25, 2018; and

WHEREAS, the City has compensated WCGC for portions of the extra work added to the Project with Change Orders 1-4, which total \$1,348,242.63; and

WHEREAS, for the claim of differing site conditions, the City knew there was asbestos in the 101 Ash Street building, and that information was included in the contract with WCGC, but the contract documents did not convey the condition of the asbestos prior to starting the Project; and

WHEREAS, due to the condition of the asbestos in the 101 Ash Street building, WCGC had to do significantly more work and expend more time than had been agreed to in their contract; and

WHEREAS, the Parties participated in non-binding mediation under the terms of the WCGC contract to try and reach a resolution of the claims brought by WCGC on the Project; and

WHEREAS, as a result of that mediation, WCGC has agreed to settle all issues, claims, and disputes filed by them against the City on this Project in exchange for payment by the City to WCGC in the amount of \$1,395,000.00; and

WHEREAS, in Closed Session on February 9, 2021, the City Council by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, and 9; Nays, District 8; Absent, None, approved the settlement of WCGC's claims against City on this Project consistent with the amount set forth below; and

WHEREAS, by agreeing to pay Final Contract Change Order No. 5, the City is not waiving any potential claims or regulatory fines against WCGC; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, Final Contract Change Order No. 5 with West Coast General Contractors for an amount not to exceed \$1,395,000.00, on file with the Office of the City Clerk as Document No.

RR-313490, contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

2. That the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP S-17009, 101 Ash Improvements, and to appropriate and expend \$1,415,405.13 from Fund 400868, Tobacco Revenue Settlement Bond Funding, for the purpose of funding Final Contract Change Order No. 5 and related Project costs.
