A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN  
JEFFREY ROBINSON AND THE CITY OF SAN DIEGO.

WHEREAS, on August 17, 2018, JEFFREY ROBINSON filed a lawsuit against the City of San Diego and San Diego Police Department [City] alleging violation of the Americans with Disabilities Act and the U.S. Constitution from the incident that occurred August 21, 2017, entitled *Jeffrey Robinson v. City of San Diego, et al.* United States District Court Case No. 18cv1918-AJB (AGS); and

WHEREAS, in Closed Session on March 9, 2021, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays, none; and absent, none, approved the Settlement for an amount consistent with the amounts set forth below;


NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$72,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the lawsuit *Jeffrey Robinson v City of San Diego, et al.* United States District Court Case No. 18cv1918-AJB (AGS).

2. Authorizes the Department of Finance to expend an amount not to exceed \$72,000.00 from the Public Liability Fund No. 720045, for the purpose of settling this claim.
