A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
LORIE COSIO-AZAR AND THE CITY OF SAN DIEGO.

WHEREAS, on May 13, 2019, LORIE COSIO-AZAR filed a lawsuit against the City of San Diego (City) for damages as a result of alleged unequal pay as a City Program Manager from September 2014 through April 2019 and retaliation for her termination on April 6, 2019, entitled *Lorie Cosio-Azar v. City of San Diego*, Superior Court of the State of California, County of San Diego, Central Division Case Number 37-2019-00024505-CU-WT-CTL; and

WHEREAS, in Closed Session on March 2, 2021, the City Council, by the following votes: Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and absent, Districts None/All Present, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$250,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees arising from the lawsuit *Lorie Cosio-Azar v. City of San Diego*, Superior Court of the State of California, County of San Diego, Central Division Case Number 37-2019-00024505-CU-WT-CTL .

2. Authorizes the Department of Finance to expend an amount not to exceed \$250,000 from Public Liability Fund No. 720045, for the purposes of settling this claim.
