A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN DOUGLAS PASHUTA AND THE CITY OF SAN
DIEGO.

WHEREAS, on December 12, 2019, DOUGLAS PASHUTA filed suit against the City of San Diego alleging excessive force arising from an interaction between him and two San Diego Police Department officers at the Embassy Hotel, 3645 Park Boulevard, in the City of San Diego, on April 2, 2019. The suit entitled *Douglas Pashuta v. City of San Diego, et al.*, United States District Court case no. 19cv2386 CAB (DEB); and

WHEREAS, in Closed Session on April 13, 2019, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and All Present, approved the Settlement for an amount consistent with the amounts set forth below;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$57,500.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the Complaint filed by Douglas Pashuta, entitled *Douglas Pashuta v. City of San Diego, et al.*, United States District Court Case No. 19cv2386 CAB (DEB).

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$57,500.00 from Public Liability Fund No. 720045, for the purpose of settling this claim.


