A RESOLUTION DETERMINING THAT THE APPROVAL OF THE FAY AND MUIRLAND PROJECT IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15305.

WHEREAS, the project which is a Public Right-of-Way Vacation to vacate portions of Fay Avenue deeded to the City of San Diego over lots 11-16 of Miramar Terrace. The lots to be vacated are located at the south-east corner of Fay Avenue and West Muirlands Drive, across the street from La Jolla High School and north of the 7000 block of Fay Avenue. The City's Real Estate Assets Department is proposing to vacate an unimproved 0.42-acre portion of Fay Avenue in La Jolla that is no longer needed along this corridor after the road was re-aligned to improve traffic flow and pedestrian access; and

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of Projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Development Services Department has established that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines section 15305 and that no exception to the exemption, as set forth in CEQA Guidelines section 15300.2, applies to the Project; and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the Project, and

WHEREAS, on May 18, 2021 the City Council held a duly noticed public meeting and considered the written record for the Project as well as public comment; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has determined that the project meets the criteria set forth in CEQA Section 15305, which allows for minor alterations to land as long as the average slope on site is less than 20 percent on average and would not result in any changes in land use or density. Since the project site does not contain slopes greater than 20 percent on average and would not change land use or increase density the exemption does apply. The site is currently developed and would not trigger any of the exceptions to categorical exemptions found in State CEQA Guidelines section 15304.2; and

WHEREAS, under San Diego Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body and where a public hearing was required by law implicating due process rights of individuals affected by the decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; NOW, THEREFORE,
