A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A CITYWIDE COOPERATIVE AGREEMENT WITH W.W. GRAINGER, INC. FOR MAINTENANCE, REPAIR, AND OPERATIONS SUPPLIES, PARTS, EQUIPMENT, AND MATERIALS.

WHEREAS, multiple City departments require maintenance, repair, and operations (MRO) supplies, including safety supplies, janitorial chemicals, tools, hardware, and lighting components, to conduct their day-to-day operations; and

WHEREAS, it is advantageous for the City to enter into cooperative agreements for commodities used by several jurisdictions due to the purchasing power that they create; and

WHEREAS, the City's Purchasing Agent has certified in writing that the cooperative agreement for MRO supplies, parts, equipment, and materials, awarded to W.W. Grainger, Inc. by The City of Tucson, in cooperation with OMNIA Partners, meets the requirements set forth in San Diego Municipal Code section 22.3208; and

WHEREAS, Purchasing & Contracting expects City departments to purchase a total of approximately \$9.5 million in MRO supplies, parts, equipment, and materials from their respective budgets over the next five years, and City Council approval is required to exceed \$3 million in purchases from a contract pursuant to San Diego Municipal Code section 22.3206(d); NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or designee is authorized to enter into an agreement with W.W. Grainger, Inc., on file in the Office of the City Clerk as Document No. RR- 313566, for the purchase of MRO supplies, parts, equipment, and materials through December 31, 2024.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$9,500,000 to provide funds to purchase as-needed MRO supplies, parts, equipment, and materials under the agreement with W.W. Grainger, Inc., contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
