A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF A FIRST AMENDMENT TO THE COOPERATIVE PROCUREMENT CONTRACT BETWEEN THE CITY OF SAN DIEGO AND DLT SOLUTIONS, LLC FOR AMAZON WEB SERVICES PRODUCTS, SERVICES, AND SOLUTIONS AND ASSOCIATED AMAZON PRODUCTS AND SERVICES.

WHEREAS, on May 1, 2016, based on the results of a national Request for Proposal (RFP) process, the County of Fairfax, Virginia, as the lead agency for the U.S. Communities Government Purchasing Alliance (now "OMNIA Partners"), awarded a contract to DLT Solutions, LLC "DLT") for Amazon Web Services (AWS) products, services, and solutions and associated Amazon products and services (Agency Agreement); and

WHEREAS, On February 26, 2019, the City's Purchasing Agent certified in writing that the Agency Agreement was in the City's best interests, was to the City's economic advantage, and was competitively awarded using a process that complied with the polices, rules, and regulations developed by the City Manager; and

WHEREAS, On May 16, 2019, under Mayoral authority for an amount not-to-exceed \$3,000,000, the City executed a cooperative procurement contract with DLT for AWS Products, Services, and Solutions and Associated Amazon Products and Services (Contract); and

WHEREAS, this action will increase the not-to-exceed amount of the Contract from \$3,000,000 to \$12,714,000, an increase of \$9,714,000, to provide sufficient expenditure authority for cloud computing services through the balance of the Contract term.; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, the First Amendment to the Cooperative Procurement Contract between the City of San Diego and DLT Solutions, LLC, for Amazon Web Services Products, Services, and Solutions and Associated Amazon Products and Services, for the purpose of increasing the not-to-exceed amount of the Contract by \$9,714,000, from \$3,000,000 to \$12,714,000 and otherwise modifying the Contract pursuant to the terms and conditions contained in the First Amendment to the Contract on file with the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$12,714,000 over the term of the Contract, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
