A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE AGREEMENT WITH DUDEK & ASSOCIATES FOR AS-NEEDED PROFESSIONAL ENVIRONMENTAL SERVICES; AND TAKING RELATED ACTIONS.

WHEREAS, this action will execute and award an Agreement for As-Needed

Professional Environmental Services to provide professional services to support the City of

San Diego's Transportation & Stormwater Department in support of Capital Improvement

Program (CIP) and ancillary projects not covered under the CIP for a maximum contract amount

not to exceed \$7,500,000, at a maximum duration of five (5) years; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an agreement with Dudek & Associates, to provide As-Needed Professional Environmental Services, in an amount not to exceed \$7,500,000, contingent upon the Chief Financial Officer first furnishing one or more certificates demonstrating that funds necessary for expenditure are, or will be, on deposit with the City Treasury, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as document No. RF-313592.
- 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$7,500,000 over five (5) years for the purpose of funding the As-Needed Professional Environmental Services agreement with Dudek & Associates, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.

- 3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from General Fund, Stormwater Department 2114.
- That the Chief Financial Officer is authorized, upon advice from the administering department, to transfer excess funds, if any, to the appropriate reserves.
