A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS AND
REAPPOINTMENTS TO THE INTERNATIONAL AFFAIRS
BOARD.

WHEREAS, the International Affairs Board (Board) is established in San Diego
Municipal Code, Chapter 2, Article 6, Division 00, section 26.22, with its powers and duties set
forth in section 26.23; and

WHEREAS, pursuant to Municipal Code section 26.23, the Board's powers and duties
include recommending and participating in programs to promote the City of San Diego's
standing as a global city, and establishing mutually beneficial ties with peoples, governments,
organizations, and institutions around the world to promote the global character of San Diego;
advising the Mayor and Council on how international issues and policies impact San Diego;
advising the Mayor and Council regarding diplomatic and protocol activities with the
international community, and engaging in programs to foster friendly relations, promoting
San Diego's global economic competitive advantages, building relationships, and advancing
cultural awareness and better understanding between the City's diverse neighborhoods and the
broader world; and

WHEREAS, the Board consists of seventeen members, including nine community
members appointed by the Mayor and confirmed by the Council of the City of San Diego, who
serve two-year terms, and may serve a maximum of four consecutive terms, and until a successor
is duly appointed and qualified; and

WHEREAS, the nine community members appointed by the Mayor shall be residents of San Diego County and qualified by training, experience or interest in international affairs; and

WHEREAS, of the nine community members appointed by the Mayor, no more than five may have terms expiring in the same year; and

WHEREAS, the Mayor, with confirmation by Council, also appoints eight members from civic organizations with international affairs involvement or expertise, who serve two-year terms and may serve a maximum of four consecutive terms, and until a successor is duly appointed and qualified; and

WHEREAS, the Mayor now seeks Council confirmation of appointments and reappointments to the Commission; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments and reappointments by the Mayor of the City of San Diego, to serve as members of the International Affairs Board, for terms expiring as indicated, are made and hereby confirmed:


