A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN INCREASE TO THE FISCAL YEAR 2022 CAPITAL IMPROVEMENT PROGRAM BUDGET WITH 2021 LEASE REVENUE BOND AND COMMERCIAL PAPER NOTE PROCEEDS TO FUND CRITICAL INFRASTRUCTURE NEEDS.

WHEREAS, on June 21, 2021, the Mayor approved Resolution No. R-313586, approving the City of San Diego's Fiscal Year 2022 Budget (2022 Budget); and

WHEREAS, on June 29, 2021, the Council of the City of San Diego (Council) adopted Ordinance No. O-21348, entitled "An Ordinance Adopting the Annual Budget for Fiscal Year 2022 and Appropriating the Necessary Money to Operate the City of San Diego for Fiscal Year 2022" (Appropriation Ordinance); and

WHEREAS, the 2022 Budget includes the annual budget for the Capital Improvement Program (CIP Budget); and

WHEREAS, Section 17 of the Appropriation Ordinance authorizes the Chief Financial Officer to modify appropriations upon adopted Council resolution, provided funding is available for such action and in accordance with funding source guidelines; and

WHEREAS, Section 73 of the San Diego City Charter allows the Council, upon the recommendation of the Mayor, to transfer all or part of an unencumbered balance of an appropriation to a purpose or object for which the appropriation for the current year has proved insufficient; and

WHEREAS, the Council desires to approve the proposed budget amendments, appropriation changes and other actions as described below; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the following revisions to the 2022 Budget are approved and the Chief Financial Officer (CFO) is directed to adjust the Fiscal Year 2022 Capital Improvement Program (CIP) budget appropriations as follows:

- 1. Increase the CIP Budget in CIP ACA00001, Drainage Projects, and to appropriate and expend \$30,351,515.00 from CIP ACA00001, Drainage Projects, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical flood resilience infrastructure projects, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 2. Increase the CIP Budget in CIP S20003, Maple Canyon SD Upgd, and to appropriate and expend \$500,000.00 from CIP S20003, Maple Canyon SD Upgd, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding design costs for the project, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 3. Increase the CIP Budget in CIP S00606, SD River Dredging Qualcomm Way to SR163, and to appropriate and expend \$100,000.00 from CIP S00606, SD River Dredging Qualcomm Way to SR163, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding design costs for the project, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

- 4. Increase the CIP Budget in CIP ACC00001, Watershed CIP, and to appropriate and expend \$17,668,000.00 from CIP ACC00001, Watershed CIP, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical green infrastructure projects, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 5. Increase the CIP Budget in CIP AIE00002, Guard Rails, and to appropriate and expend \$280,000.00 from CIP AIE00002, Guard Rails, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical Guardrail projects, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 6. Increase the CIP Budget in CIP AIH00001, Installation of City Owned Street
 Lights, and to appropriate and expend \$1,000,000.00 from CIP AIH00001,
 Installation of City Owned Street Lights, Fund 400881, Debt Funded General
 Fund CIP Projects, for the purpose of funding critical Streetlight projects,
 contingent upon the Chief Financial Officer furnishing one or more certificates
 certifying that the funds necessary for expenditure are, or will be, on deposit with
 the City Treasurer; and
- 7. Increase the CIP Budget in CIP AIK00003, Sidewalk Repair, and to appropriate and expend \$4,790,000.00 from CIP AIK00003, Sidewalk Repair, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical Sidewalk projects, contingent upon the Chief Financial Officer furnishing one or

- more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 8. Increase the CIP Budget in CIP P18007, Alvarado Road Realignment, and to appropriate and expend \$4,000,000.00 from CIP P18007, Alvarado Road Realignment, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding the project planning of the Alvarado Road Realignment, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 9. Increase the CIP Budget in CIP S00905, SR 163/Clairemont Mesa Blvd
 Interchange, and to appropriate and expend \$99,765.00 from CIP S00905, SR
 163/Clairemont Mesa Blvd Interchange, Fund 400881, Debt Funded General
 Fund CIP Projects, for the purpose of funding close out costs for the project,
 contingent upon the Chief Financial Officer furnishing one or more certificates
 certifying that the funds necessary for expenditure are, or will be, on deposit with
 the City Treasurer; and
- 10. Increase the CIP Budget in CIP AID00005, Street Resurfacing, and to appropriate and expend \$39,510,000.00 from CIP AID00005, Street Resurfacing, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical Street Resurfacing projects, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

- 11. Further increase the CIP Budget in CIP AID00005, Street Resurfacing, and to appropriate and expend \$482,000.00 from CIP AID00005, Street Resurfacing, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical resurfacing of street segments adjacent to and impacted by UU973

 Undergrounding Project, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 12. Increase the CIP Budget in CIP AIH00002, Streetlight Circuit Upgrades, and to appropriate and expend \$9,300,000.00 from CIP AIH00002, Streetlight Circuit Upgrades, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical Circuit Upgrade projects, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 13. Increase the CIP Budget in CIP AIL00005, Traffic Signals Modifications, and to appropriate and expend \$400,000.00 from CIP AIL00005, Traffic Signals Modifications, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical Traffic Signal projects, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

Increase the CIP Budget in CIP AGF00005, Regional Parks, and to appropriate and expend \$2,700,000.00 from CIP AGF00005, Regional Parks, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical Parks projects, contingent upon the Chief Financial Officer furnishing one or more

Increase the CIP Budget in CIP AGF00006, Coastal Erosion and Access, and to appropriate and expend \$2,131,947.00 from CIP AGF00006, Coastal Erosion and Access, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical Coastal projects, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- Improvements, and to appropriate and expend \$12,572,844.00 from CIP S20005,
 Balboa Park Botanical Bldg Improvements, Fund 400881, Debt Funded General

 contingent upon the Chief Financial Officer furnishing one or more certificates

Increase the CIP Budget in CIP S14017, Fire Station No. 51 Skyline Hills, and to appropriate and expend \$250,000.00 from CIP S14017, Fire Station No. 51 Skyline Hills, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding design costs for the project, contingent upon the Chief

- Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

Increase the CIP Budget in CIP S20015, Ocean Beach Branch Library, and to appropriate and expend \$470,000.00 from CIP S20015, Ocean Beach Branch Library, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding design costs for the project, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 23. Increase the CIP Budget in CIP S00800, San Carlos Branch Library, and to appropriate and expend \$470,000.00 from CIP S00800, San Carlos Branch Library, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding design costs for the project, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 24. Increase the CIP Budget in CIP ATT00001, Governmental IT, and to appropriate and expend \$550,000.00 from CIP ATT00001, Governmental IT, Fund 400881, Debt Funded General Fund CIP Projects, for the purpose of funding critical Information Technology projects, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and
- 25. Increase the CIP Budget in CIP AGF00007, Park Improvements Annual Allocation, and to appropriate and expend \$500,000.00 from CIP AGF00007, Park Improvements Annual Allocation, Fund 400881, Debt Funded General Fund

CIP Projects, to support the repairs to Willie Henderson Recreation Center caused by a fire, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
