A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING EXECUTION OF A
COOPERATIVE PROCUREMENT CONTRACT WITH
VELOCITY TRUCK CENTERS FOR CRANE CARRIER
COMPANY CLASS 4-8 CHASSIS WITH RELATED
EQUIPMENT, ACCESSORIES, AND SERVICES.

WHEREAS, the City of San Diego’s Department of General Services, Fleet Operations Division (Fleet Operations Division) operates and maintains a fleet of over 4,600 vehicles and equipment to support all City of San Diego (City) services and is responsible for the maintenance, repair, acquisition, and replacement of the City’s fleet; and

WHEREAS, the Fleet Operations Division provides a fleet of 32 rear loader refuse collection vehicles for the City’s Environmental Services Department; and

WHEREAS, the Fleet Operations Division anticipates the replacement of seven (7) and an addition of eleven (11) rear loader refuse collection vehicles over the term of this contract; and

WHEREAS, Sourcewell issued Request for Proposal (RFP) Number 060920 for Class 4-8 Chassis with Related Equipment, Accessories, and Services; and

WHEREAS, on August 7, 2020, based on the results of the competitive process, Sourcewell awarded a contract with Crane Carrier Company (CRN) and executed the RFP Number 060920 for Class 4-8 Chassis with Related Equipment, Accessories, and Services Contract with CRN, identified as Sourcewell RFP Number 060920 – CRN (hereinafter referred to as “Agency Agreement”); and

WHEREAS, the City’s Purchasing Agent has certified in writing that the cooperative contract for Class 4-8 Chassis with Related Equipment, Accessories, and Services meets the

requirements set forth in San Diego Municipal Code section 22.3208. The Sourcewell RFP Number 060920 – CRN Contract is in the City’s best interests; the contract is to the City’s economic advantage; and the contract was competitively awarded using a process that complies with the policies, rules, and regulations developed by the City Manager; and

WHEREAS, Crane Carrier Company represents that the authorized dealer for the City for purposes of this contract is Velocity Truck Centers, and that City must purchase the goods and services through Velocity Truck Centers. Velocity Truck Centers will provide the goods and services to be procured under this contract; and

WHEREAS, Velocity Truck Centers has agreed to provide to City the same pricing offered to Sourcewell for the procurement of Class 4-8 Chassis with Related Equipment, Accessories, and Services consistent with the terms and conditions in the Agency Agreement. As an authorized dealer of Crane Carrier Company, Velocity Truck Centers is authorized to utilize the Sourcewell RFP Number 060920 – CRN Contract and its pricing to meet the needs of the City; and NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a cooperative procurement contract with Velocity Truck Centers to purchase Crane Carrier Company Class 4-8 Chassis with Related Equipment, Accessories, and Services for the City’s refuse collection fleet on an as-needed basis, in an amount not-to-exceed \$9,600,000, for a term extending through August 1, 2024, with an option to extend for one additional year, pursuant to the terms and conditions set forth in the Contract, on file with the Office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$9,600,000 from the applicable Fleet Operations Vehicle Replacement Funds (Funds Numbers 720002 through 720037, and 720058 through 720059), over the term of the Contract which includes the option to extend for one additional year, to purchase Crane Carrier Company Class 4-8 Chassis with Related Equipment, Accessories, and Services, contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
