Authorizes the Mayor or his designee to pay the sum of \$250,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from Cynthia Mitchell's employment with the City of San Diego.

2. Authorizes the Chief Financial	Officer to expend an amount not to exceed
\$250,000 from Public Liability Fund No. 720	045, for the purpose of settling this claim.
