A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE AUTHORIZATION OF THE EXECUTION OF THE PROPERTY MANAGEMENT AGREEMENT BETWEEN MEISSNER JACQUET REAL ESTATE MANAGEMENT GROUP, INC. AND THE CITY OF SAN DIEGO FOR PROPERTY MANAGEMENT SERVICES FOR THE REAL PROPERTIES LOCATED AT 1200 THIRD AVENUE, 201 A STREET, AND 101 ASH STREET, SAN DIEGO, CALIFORNIA IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15301.

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Planning Department has established that the Project is categorically

exempt from CEQA pursuant to CEQA Guidelines section 15301 (Existing Facilities) and that

no exception to the exemption, as set forth in CEQA Guidelines section 15300.2, applies to the

Project; and

WHEREAS, the Council of the City of San Diego (Council) has considered the potential

environmental effects of the Project; and

WHEREAS, the Council held a duly noticed public meeting and considered the written

record for the Project as well as public comment; and

WHEREAS, the Council, using its independent judgment, has determined that the Project

is categorically exempt from CEQA, pursuant to CEQA Guidelines section 15301 (Existing

Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing, or

minor alterations of existing public or private structures or facilities involving negligible or no

expansion of existing or former use; NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego, using its independent

judgment, has considered the written record and public comment for the requested authorization

and determines that the Project is categorically exempt from CEQA pursuant to State CEQA

Guidelines Section 15301, and that an exception to the exemption as set forth in CEQA

Guidelines 15300.2 does not apply.
