### A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN DONNA MARK AND THE CITY OF SAN DIEGO.

WHEREAS, on June 6, 2019, Donna Mark filed suit against the City of San Diego, alleging personal injury arising from a trip and fall on a water valve cover located at the Tintersection of Blue Lake Drive and Ruby Lake Avenue, in the City of San Diego. The suit is entitled *Donna Mark v. City of San Diego*, San Diego Superior Court Case No. 37-2019-00028971-CU-PO-CTL; and

WHEREAS, in Closed Session on July 27, 2021, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and All Present, approved the settlement for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

- Authorizes the Mayor or his designee to pay the sum of \$85,000 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents, employees, and contractors, arising from the personal injury complaint filed by Donna Mark.
- Authorizes the Chief Financial Officer to expend \$85,000 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizes the Comptroller to issue a check in the amount of \$85,000, made payable

to Kelly Law and Donna Mark.
