A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ADOPTING THE 2022 LEGISLATIVE
CALENDAR AND THE FISCAL YEAR 2023 BUDGET
DEVELOPMENT AND FISCAL YEAR 2022 BUDGET
MONITORING KEY DATES.

WHEREAS, each year, the Council of the City of San Diego (Council) adopts a schedule of meetings for the Council and Council Standing Committees for the calendar year, commonly referred to as the legislative calendar; and

WHEREAS, the Council also desires to schedule the meetings of the Budget Review Committee and adopt a calendar that includes the meetings of the Housing Authority and the Public Facilities Financing Authority; and

WHEREAS, the Council desires to adopt a schedule for the Fiscal Year 2023 Budget Development and Fiscal Year 2022 Budget Monitoring Key Dates as approved by the Budget and Government Efficiency Committee on September 15, 2021; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the schedule of meetings for the Council, Standing Committees, and Budget Review Committee of the City Council, and includes meetings of the Housing Authority and Public Facilities Financing Authority, for the period of January 1, 2022 through December 31, 2022, a copy of which is on file in the Office of the City Clerk as Document No. RR- 313743¹, is hereby adopted.

BE IT FURTHER RESOLVED, that the Fiscal Year 2023 Budget Development and Fiscal Year 2022 Budget Monitoring Key Dates, as approved by the Budget and Government Efficiency Committee, a copy of which is on file in the Office of the City Clerk as Document No. RR- 313743⁻², is hereby adopted.


