WHEREAS, in Closed Session on July 13, 2021, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, and 9; Nays, 8; and All Present, approved the settlement for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1) Authorizes the Mayor or his designee to pay the sum of \$3,000,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the Complaint entitled S.R. Nehad, K.R. Nehad, and the Estate of Fridoon Rawshan Nehad v. City of San Diego et al., United States District Court Case No. 15cv1386 TWR.

2) Authorizes the Chief Financial (Officer to expend an amount not to exceed
\$3,000,000.00 from Public Liability Fund No.	720045, for the purpose of settling this claim.
