BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

Authorizes the Mayor or his designee to pay the sum of \$116,597.83 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the lawsuit *Anne Marie Welsh v. City of San Diego*, San Diego Superior Court Case No. 37-2019-00059241-CU-PO-CTL.
