A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY OF SAN DIEGO REDISTRICTING COMMISSION RETENTION OF OUTSIDE COUNSEL TO REVIEW PROPOSED MAPS AND PROVIDE VOTING RIGHTS ACT AND RACIALLY POLARIZED VOTING ANALYSIS.

WHEREAS, the City of San Diego (City) Charter (Charter) section 5 requires that the City be redistricted at least once every 10 years, but no later than nine months following the City's receipt of final Federal Decennial Census information; and

WHEREAS, Charter section 5.1 provides the procedure for redistricting, and calls for the creation of a nine-member Redistricting Commission (Commission), which has sole and exclusive authority to adopt the redistricting plan that sets the boundaries of City Council districts; and

WHEREAS, due to the unusual and complex nature of the legal issues involved in the redistricting process, the City Attorney's Office does not have the necessary expertise to advise the Commission on questions related to the Voting Rights Act and racially polarized voting analysis; and

WHEREAS, the Commission seeks to engage outside counsel to assist in its redistricting efforts; and the City, pursuant to San Diego Municipal Code section 22.3202(a) issued Request for Proposal Number 10089814-22-V Legal Counsel for the Redistricting Commission; and WHEREAS, the selected proposer was Richards, Watson & Gershon; and

WHEREAS, at its regular meeting on October 21, 2021, the Commission voted to

approve the retention of Richards, Watson & Gershon as outside counsel and approved the

Contract Resulting from Request for Proposal Number 10089814-22-V Legal Counsel for the

Redistricting Commission; and

WHEREAS, Richards, Watson, & Gershon has the necessary skills and experience to

assist the City in this matter; and

WHEREAS, the contract is for an amount not to exceed \$70,000, to be paid from General

Fund 100000, Funds Center 9912001122; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Redistricting

Commission, via the City Attorney's Office, is authorized to retain Richards, Watson & Gershon

as outside counsel to provide legal services related to the Voting Rights Act and racially

polarized voting data in the 2020-21 redistricting process.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego that the Chief

Financial Officer or his designee is authorized to appropriate and expend an amount not to

exceed \$70,000.00 from the General Fund 100000, Funds Center 9912001122 for the retention

of Richards, Watson & Gershon as outside counsel, contingent upon the Chief Financial Officer

first issuing one or more certificates certifying that the funds necessary for expenditure are, or

will be, on deposit in the City Treasury.
