AN ORDINANCE AUTHORIZING THE OBLIGATIONS OF CONSTRUCTION CONTRACT K-15-5716-DBB-3, FOR WBS NO. S-11021, UNIVERSITY AVE. PIPELINE REPLACEMENT, WITH BURTECH PIPELINE, INC. TO EXTEND BEYOND FIVE YEARS FOR AN ADDITIONAL 34 MONTHS, FOR A NOT TO EXCEED TOTAL OF 7 YEARS AND 10 MONTHS.

WHEREAS, the University Avenue Pipeline Replacement Project (Project) is part of the

City of San Diego's Public Utilities Department Capital Improvement Program; and

WHEREAS, the City's continuing effort to replace all the cast iron pipelines within the City is in accordance with California Department of Public Health compliance order 04-14-96CO-022; and

WHEREAS, this project was driven by the need to replace cast iron pipes that have reached the end of their useful life; and

WHEREAS, the Project Scope of Work includes, but is not limited to, replacement of 4.33 miles of cast iron pipeline; traffic control; storm water pollution and prevention; replacement of all existing water services; replacement and construction of additional fire hydrants; and installation of new blow off valves, air release valves, and other hydraulic components necessary to complete the work as specified in the plans and specifications; and

WHEREAS, the City entered into a contract for University Ave. Pipeline Replacement (K-15-5716-DBB-3) with Burtech Pipeline, Inc. (Burtech), on February 20, 2015, for an amount not to exceed \$19,354,365 (Contract); and

WHEREAS, the Project encountered various challenges which has required construction obligations of the Contract to continue beyond the 5-year mark; and

WHEREAS, this Action is to approve a 34-month, no-cost extension of the obligations contained in the Contract to December 20, 2022; and

WHEREAS, under Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a twothirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the City Council hereby authorizes the obligations under the Contract to extend beyond five years. However, in no event shall the obligations extend beyond December 20, 2022.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
