DATE OF FINAL PASSAGE JAN 27 2022

AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO THE AS-  
NEEDED LANDSCAPE ARCHITECTURAL DESIGN CONSULTANT  
AGREEMENT WITH SCHMIDT DESIGN GROUP, INC. (H166714).

WHEREAS, the City of San Diego (City) entered into an as-needed professional services agreement with Schmidt Design Group, Inc. (Schmidt) on March 17, 2017 for landscape architectural design services to support the City's Capital Improvement Projects; and

WHEREAS, Schmidt has received 19 tasks under the current agreement, of which the following 6 tasks are still either in design or in construction: Clay Avenue Mini Park Improvements, Sherman Heights Community Center Playground, Beyer Park Development, Fairbrook Neighborhood Park Development, Riviera Del Sol Neighborhood Park, and North Cove Comfort Station Improvements; and

WHEREAS, to complete these 6 tasks the agreement with Schmidt will need to be amended to add time to their agreement, which will take their agreement beyond five years; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the First Amendment to the Agreement with Schmidt Design Group, Inc. to extend the contract duration from 60 months to 108 months, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury, under the terms and conditions set forth in the First

Amendment to the Agreement, on file in the Office of the City Clerk as Document No. OO-  
21420.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
