DATE OF FINAL PASSAGE FEB 03 2022

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE OBLIGATIONS OF
CONSTRUCTION CONTRACT K-16-1423-DBB-3, FOR WBS
NO. B-11023, NAVAJO PUMP STATION, WITH TC
CONSTRUCTION COMPANY, INC. TO EXTEND BEYOND
FIVE YEARS FOR AN ADDITIONAL 19 MONTHS.

WHEREAS, the City entered into a contract for Navajo Pump Station with TC
Construction Company, Inc. on May 19, 2016 (K-16-1423-DBB-3) (Contract); and

WHEREAS, the original Contract duration was for 300 working days with a Notice to
Proceed date of July 18, 2016; and

WHEREAS, the majority of the construction activities were completed between May
2016 and May 2021, which included all previous change order items of additional scope, design
revision and construction re-work to provide back-up for the San Carlos Reservoir, coordination
with SDGE for gas line conflicts, and TSW paving upgrades; and

WHEREAS, during the initial testing of the pump station in March 2021, it was
determined that additional electrical work and revisions to the programming are required in order
to complete the pump station testing; and

WHEREAS, the City now desires to extend the Contract 19 months beyond the five-year
mark, May 20, 2021, to allow time for the completion of the remaining electrical and
programming work required for the pump station's operational acceptance, and is intended to
allow time contingency for potential unknowns through the final construction and to allow for
redlines, as-builts, and other close out items; and

WHEREAS, under Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the City Council hereby authorizes the obligations of the contract for Navajo Pump Station with TC Construction Company, Inc. (K-16-1423-DBB-3) to extend beyond five years for an additional 19 months, however, in no event shall the obligations extend beyond December 19, 2022.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
