AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE OBLIGATIONS OF CONSTRUCTION CONTRACT K-16-1431-DBB-3, FOR WBS NO. S-12040, TIERRASANTA PUMP STATION, WITH J. F. SHEA CONSTRUCTION, INC. TO EXTEND BEYOND FIVE YEARS FOR AN ADDITIONAL 12 MONTHS, FOR A NOT TO EXCEED TOTAL OF 6 YEARS.

WHEREAS, the City entered into a contract for the Tierrasanta Pump Station project (Project) with L. H. Woods and Sons, Inc. on December 5, 2016 for an amount not to exceed \$10,995,000 (K-16-1431-DBB-3); and

WHEREAS, the Project consists of construction of a new 14-MGD pump station located at 4701 Seda Drive (Tierrasanta Pump Station), installation of approximately 3000 feet of 20inch PVC water main along Clairemont Mesa Blvd., and demolition of the existing Tierrasanta Temporary Pump Station located at 11100 Clairemont Mesa Blvd.; and

WHEREAS, during construction, J. F. Shea Construction, Inc., purchased L. H. Woods

and Sons, Inc., and with the purchase acquired the remainder of the construction contract; and

WHEREAS, the Project encountered various challenges which required construction

activities to go beyond the anticipated completion date; and

WHEREAS, this action will authorize contract K-16-1431-DBB-3 with J. F. Shea Construction, Inc., to extend 12 months beyond the five (5) year contract term, which currently expires on December 5, 2021; and

WHEREAS, the new contract end date will be December 5, 2022; and

WHEREAS, under Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a twothirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the City Council hereby authorizes the obligations of construction contract K-16-1431-DBB-3, for WBS No. S-12040, Tierrasanta Pump Station, with J. F. Shea Construction, Inc. to extend beyond five years for an additional 12 months, for a not to exceed total of 6 years. However, in no event shall the obligations extend beyond December 20, 2022.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
