AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE APPLICATION TO THE CALIFORNIA DEPARTMENT OF WATER RESOURCES FOR THE FY 2021 HIGH HAZARD POTENTIAL DAM REHABILITATION GRANT.

WHEREAS, an application is required to apply for, accept, appropriate and expend grant funds for the High Hazard Potential Dam (HHPD) Rehabilitation Grant Program with the State of California's Department of Water Resources (DWR), funded by the Federal Emergency Management Agency (FEMA), U.S. Department of Homeland Security (DHS), and this action requires an ordinance as the grant reporting requirements exceed 5 years; and

WHEREAS, the National Dam Safety Program (NDSP) funds the Rehabilitation Grant Program for FY 2021 that provides financial assistance for pre-construction activities for dams identified by the state as a "High" or "Extremely High" hazard potential, and funding will support FEMA's objective to protect lives and property from the risks associated with dams; and

WHEREAS, the Public Utilities Department (PUD) has been selected to receive funding for pre-construction activities for the Hodges, El Capitan, Barrett, Savage (Otay), and Morena dams; and

WHEREAS, the HHPD Grant will assist the City in offsetting expenses and ensure the City continues to be proactive in maintaining safe infrastructure for all residents and industries within dam inundation zones and in addition to being awarded FY 2021 funds, the City has also been awarded \$260,484 in FY 2019 and \$178,750 in FY 2020; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or designee, is authorized to execute, for and on behalf of the City, a financial assistance application to the State of California Department of Water Resources and to take all necessary actions to secure funding in an amount not to exceed \$536,798 in Federal Emergency Management Agency (FEMA), Department of Homeland Security (DHS) grant funds, for the Rehabilitation of High Hazard Potential Dams (HHPD), under the terms and conditions set forth in the financial assistance application, on file in the Office of the City Clerk as Document No. OO-

Section 2. That the Chief Financial Officer is authorized to accept, appropriate and expend an amount not to exceed \$536,798 from the State of California Department of Water Resources (DWR), Rehabilitation of High Hazard Potential Dams (HHPD) Program.

Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
