DATE OF FINAL PASSAGE JUL 21 2022

AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO EXEMPTING ONE PROGRAM COORDINATOR  
POSITION IN THE OFFICE OF THE CHIEF OPERATING  
OFFICER FROM THE CLASSIFIED SERVICE.

WHEREAS, on June 2, 2022, the Civil Service Commission of the City of  
San Diego (City) reviewed a request from the Office of the Chief Operating Officer  
(Department) to exempt one Program Coordinator position from the Classified Service; and

WHEREAS, the Program Coordinator position will be responsible for overseeing the  
development of the City's language access policy. This position will provide support to the  
Office of Immigrant Affairs to meet goals of the Welcoming SD Implementation Plan; develop  
the language access policy and address language gaps for City staff and the community; establish  
an internal language access working group with City departments; collaborate with City  
departments on accessibility, translation needs, and evaluating progress; represent the City in  
community forums and with regional partners; and develop policies to implement the language  
access policy; and

WHEREAS, San Diego City Charter (Charter) section 117 states the Unclassified Service  
shall include “[m]anagerial employees having significant responsibilities for formulating or  
administering departmental policies and programs. Each such position shall be exempted from  
the Classified Service by ordinance, upon the initiation of the appropriate appointing authority  
and after receiving the advisory review and comment of the Civil Service Commission and the  
approval of the City Council”; and

WHEREAS, upon review of the duties and responsibilities of the Program Coordinator position, as described by the Department, the Civil Service Commission found it meets the intent of Charter section 117 to exempt the position from the Classified Service; and

WHEREAS, the finding by the Civil Service Commission is set forth in the memorandum dated June 3, 2022 to the Honorable Council President and members of the City Council (Council), prepared on behalf of the Civil Service Commission by the Personnel Director, on file in the Office of the City Clerk as Document No. OO- 21491; NOW,

THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That pursuant to Charter section 117, the Council exempts from the Classified Service the one Program Coordinator position described by the Department.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


