

ORDINANCE NUMBER O- 21527 (NEW SERIES)DATE OF FINAL PASSAGE SEP 21 2022

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A FIRST AMENDMENT TO THE CONSULTING AGREEMENT WITH JANELLE IGLESIAS FOR THE PACIFIC HIGHLANDS RANCH BRANCH LIBRARY PUBLIC ART PROJECT (CONTRACT NO. H187020).

WHEREAS, through its Public Art Program, the City of San Diego (City) promotes artistic development and transforms the built environment of the City's public buildings and spaces through the inclusion of public art in capital improvement projects that enrich the everyday lives of San Diego's residents, visitors, and employees; and

WHEREAS, the City entered into an agreement on March 7, 2019, for an amount not to exceed \$165,000 to retain the services of the professional artist Janelle Iglesias to provide consulting services for the creation of a site-specific public artwork under contract No. H187020 (Agreement) for the Pacific Highlands Ranch Branch Library (Project); and

WHEREAS, Janelle Iglesias worked with the City, Project design team, Commission for Arts and Culture and its Public Art Committee, and general public to develop artwork for the Project; and

WHEREAS, the design for the artwork has since been completed, and the fabrication phase of the project started on November 13, 2020; and

WHEREAS, the Project encountered various schedule delays that required delay of the artwork fabrication and installation activities beyond the initial five-year period of the Agreement; and

WHEREAS, completion of the overall project is now anticipated in fall of 2024; and

WHEREAS, under San Diego City Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by ordinance approved by a two thirds majority vote of the Council of the City of San Diego; and

WHEREAS, with the approval of this action, the First Amendment to the Agreement will extend the term of the Agreement with Janelle Iglesias to December 31, 2024, and amend any applicable Exhibits accordingly; and

WHEREAS, an extension of this Agreement is necessary to complete artwork fabrication, as well as transportation to, and installation of, the artwork at the site; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego (Council), as follows:

Section 1. That the Mayor, or his designee, is hereby authorized and directed to execute a First Amendment to the Consulting Agreement with Janelle Iglesias, on file in the Office of the City Clerk as Document No. 00-21527, to extend the Agreement duration to December 31, 2024, and amend any applicable Exhibits accordingly.

Section 2. That a full reading of this Ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.
