DATE OF FINAL PASSAGE SEP 21 2022

AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO EXEMPTING ONE PROGRAM MANAGER  
POSITION IN THE OFFICE OF THE CITY ATTORNEY FROM  
THE CLASSIFIED SERVICE.

WHEREAS, on July 7, 2022, the Civil Service Commission of the City of San Diego (City) reviewed a request from the Office of the City Attorney (Department) to exempt one Program Manager position from the Classified Service; and

WHEREAS, the Program Manager position will develop policies to support and expand the Criminal Division's Conservatorship and Treatment Unit using legislated options to include court ordered conservatorships; develop assessment tools to address the needs of individuals who cannot provide for their own health, nutrition, and shelter because of cognitive or physical disabilities; coordinate services for those referred to the unit; coordinate the unit work of the Lifesaving Intervention For Treatment (LIFT) Program and its service providers; and propose solutions to change inequities and oversight in the current system and make such recommendations to the Chief Deputy City Attorney; and

WHEREAS, San Diego City Charter (Charter) section 117 states the Unclassified Service shall include “[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council”; and

WHEREAS, upon review of the duties and responsibilities of the Program Manager position, as described by the Department, the Civil Service Commission found it meets the intent of Charter section 117 to exempt the position from the Classified Service; and

WHEREAS, the finding by the Civil Service Commission is set forth in the memorandum dated July 8, 2022 to the Honorable Council President and members of the City Council (Council), prepared on behalf of the Civil Service Commission by the Personnel Director, on file in the Office of the City Clerk as Document No. OO-21534; NOW,

THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That pursuant to Charter section 117, the Council exempts from the Classified Service the one Program Manager position described by the Department.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.






