AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO AS-NEEDED CONTRACT H176852 WITH KITCHELL CEM FOR CONSTRUCTION MANAGEMENT SERVICES ASSOCIATED WITH EXECTUTION OF THE CITY'S MUNICIPAL ENERGY STRATEGY.

WHEREAS, the City has set a goal to bring all municipal buildings and operations to zero emissions by 2035, as established in the City's Municipal Energy Strategy and reinforced in the draft 2022 Climate Action Plan update; and

WHEREAS, in order to understand the scope and costs of these retrofits, the

Sustainability and Mobility Department, in collaboration with Asset Managing Departments and
the Department of General Services, is pursuing decarbonization and EV infrastructure
assessments for all of its existing facilities, including but not limited to Libraries, Police Stations,
Fire Stations, Public Utilities Department Facilities, Parks and Recreation Facilities, and shared
facilities; and

WHEREAS, As-Needed Contract H176852 with Kitchell CEM for construction management services (Contract) was approved by City Council Resolution RR-311322 on September 19, 2017 and fully executed on May 18, 2018, with a term of five years and a not-to-exceed value of \$1,000,000: and

WHEREAS the City has additional construction management service requirements at this time that are beyond the initial Contract provision, and the parties desire to amend the Contract to provide an extension of term for an additional two years and to increase the total authorized expenditure by an additional \$3,000,000, bringing the total term to seven years and total authorized expenditure to \$4,000,000; and

WHEREAS, under Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this ordinance based on the information provided by City staff with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or designee, is authorized to execute a First Amendment to the As-Needed Contract H176852 with Kitchell CEM, providing for an additional Contract amount not to exceed \$3,000,000 and an extension of the term for an additional two years, bringing the total authorized maximum cost of the Contract to \$4,000,000 and the total Contract term to seven years.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$3,000,000 from the Energy Conservation Fund 200224 and an amount not to exceed \$1,000,000 from the Fleet Operations Operating Budget Fund 720000 for the purpose of executing this First Amendment to the Contract, contingent upon inclusion of the annual authorized expenditure for the Contract in the adopted Appropriation Ordinance for the applicable fiscal years, and contingent upon the Chief Financial Officer furnishing a certificate certifying the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.
