AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO FOR THE FIRST AMENDMENT TO THE AS-
NEEDED CIVIL ENGINEERING SERVICES AGREEMENT
WITH PARSONS TRANSPORTATION GROUP (H176828) TO
EXTEND TIME.

WHEREAS, the City of San Diego (City) entered into an as-needed professional services agreement with Parsons Transportation Group (Parsons) on September 27, 2017 for civil engineering design services to support the City's Capital Improvement Projects. These services include, but are not limited to, preparation of construction drawings, contract documents, construction period services, and preparation of various reports; and

WHEREAS, Parsons has received twelve (12) tasks under the current agreement, of which the following one (1) task is still in design and in construction: Harbor Drive Trunk Sewer Upgrade. This task is still under design and construction and need additional time to complete resulting in a request for an extension from 60 months to 108 months; and

WHEREAS, to complete this remaining task in the agreement with Parsons, the agreement will need to be amended to add time, which will take their agreement beyond five years; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; and

WHEREAS, the Office of the City Attorney has drafted this ordinance based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the First Amendment to the Agreement with Parsons to extend the contract duration from 60 months to 108 months, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury, under the terms and conditions set forth in the First Amendment to the Agreement, on file in the Office of the City Clerk as Document No. OO- 21550

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
