ORDINANCE NUMBER O- 21566 (NEW SERIES) DATE OF FINAL PASSAGE NOV 03 2022

AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 2, DIVISION 14 OF THE SAN DIEGO MUNICIPAL CODE BY RETITLING DIVISION 14, AND ADDING A NEW SECTION 22.1406, ESTABLISHING THE STRATEGIC CAPITAL PROJECTS DEPARTMENT AS A CITY DEPARTMENT IN THE ADMINISTRATIVE CODE.

WHEREAS, San Diego Charter (Charter) section 26 requires the Council of the City of San Diego (Council) to include an Administrative Code in the San Diego Municipal Code describing the detailed powers and duties of City administrative offices and departments; and

WHEREAS, this Ordinance establishes a new City department named the Strategic Capital Projects Department, to assist the Mayor and Council with the delivery of complex, large capital projects that are beyond the core focus of the Engineering and Capital Projects Department and are strategic to the City's mission and objectives; and

WHEREAS, the Strategic Capital Projects Department will provide a full range of services such as planning, designing, engineering, project and construction management, quality assurance and inspection, contract management, Project Labor Agreement oversight, and fund management for complex, large capital projects; and

WHEREAS, the Office of the City Attorney has drafted this Ordinance based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, under Charter section 26, the Council must approve, by a two-thirds vote, an ordinance to establish new departments in the Administrative Code; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 2, Article 2, Division 14 of the San Diego Municipal Code is amended by retitling Division 14, and adding new section 22.1406, to read as follows:

Article 2: Administrative Code

Division 14: Public Utilities Department, Engineering and Capital Projects Department, Transportation Department, Environmental Services Department, Stormwater Department, and Strategic Capital Projects Department

§22.1406 Strategic Capital Projects Department

- (a) The Strategic Capital Projects Department is a City department. The department is responsible for supporting the delivery of complex, large capital projects that are beyond the core focus of the Engineering and Capital Projects Department and are strategic to the City's mission and objectives.
- (b) The Director of the Strategic Capital Projects Department is the administrative head of the department and is appointed by, and may be removed by, the City Manager. The Director is the appointing authority of all personnel authorized in the department.
- (c) The Strategic Capital Projects Department, under the direction of the City Manager, with policy direction from the City Council, is responsible for performing those duties and functions assigned and directed by the City Manager, including the direct management of the City's large, complex capital projects and the oversight of capital projects led by other organizations under an agreement.

Section 2. That a full reading of this Ordinance is dispensed with prior to passage, a

written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this Ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
