A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT WITH HOLLAND & KNIGHT LLP FOR FEDERAL LEGISLATIVE AND EXECUTIVE BRANCH CONSULTING SERVICES AND REPRESENTATION, AND TO EXECUTE A CONCURRENT AND FUTURE CONFLICT OF INTEREST WAIVER.

WHEREAS, on August 19, 2021, the City of San Diego (City) issued Request for Proposal No. 10089823-22-V (RFP) for consultant advocacy services before Federal legislative and executive branch decision-makers; and

WHEREAS, the City received five responses to the RFP; and

WHEREAS, Holland & Knight LLP (Consultant) submitted a response to the RFP and was selected as the best provider for Federal legislative and executive branch consulting services and representation based on the evaluation criteria and the City desires to award the Consultant with a contract for Federal legislative and executive branch consulting services (Contract); and

WHEREAS, this Contract will be for five years, in an amount not to exceed \$168,000 per year with a total amount not to exceed \$840,000 for the entire term, under the terms and conditions of the Contract; and

WHEREAS, in its response to the RFP, the Consultant requested the City execute a conflict of interest waiver for current and future conflicts related to its services under the Contract; and

WHEREAS, this Contract and the conflict of interest waiver were considered by the Economic Development and Intergovernmental Relations Committee on January 12, 2022, and passed to the full Council by unanimous vote; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute a contract with Holland

& Knight LLP for Federal Legislative and Executive Branch Consulting Services in the amount

of \$840,000, under the terms and conditions set forth in the Contract, on file in the Office of the

City Clerk as Document No. RR-313864

2. That the Mayor, or his designee, is authorized to execute the Concurrent and

Future Conflict of Interest Waiver, on file in the Office of the City Clerk as Document No.

RR- 313864-2

3. That the Chief Financial Officer is authorized to expend an amount not to exceed

\$168,000 each year for five years, for a total amount not to exceed \$840,000, for the purposes of

funding the Contract with Holland & Knight LLP, contingent upon the adoption of the Annual

Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial

Officer first furnishing one or more certificates certifying that funds necessary for expenditure

are, or will be, on deposit with the City Treasurer.
