A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$13,000 TO THE AMERICAN ACADEMY OF PEDIATRICS, CALIFORNIA CHAPTER 3, FOR THE REACH OUT AND READ PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the American Academy of Pediatrics CA Chapter 3 (AAP-CA3) has requested funding for the Reach Out and Read San Diego (RORSD) program; and

WHEREAS, the requested funding will be used to purchase books for distribution at RORSD clinics so doctors can prescribe books and encourage families to read together every day; and

WHEREAS, AAP-CA3's request for funding of the RORSD program will benefit the public by preparing children for Kindergarten giving them a jump start in literacy; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 3, 5, 6, and 8 recommend a total allocation of \$13,000 to AAP-CA3 for the purposes set forth in this resolution, attributed as follows: Council District 3 – \$1,000; Council District 5 – \$4,000; Council District 6 – \$3,000; and Council District 8 – \$5,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2022 City Council Allocations Agreement between the City of San Diego and the American Academy of Pediatrics CA Chapter 3 (Agreement) in an amount not to exceed \$13,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 313909.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from Council District 3: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1103110003; \$4,000 from Council District 5: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1105110005; \$3,000 from Council District 6: Community Projects, Programs and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center No. 1106110006; and \$5,000 from Council District 8: Community Projects, Programs and Services budget Fund No. 512059, Cost

Center No. 1108110008, for a total of \$13,000, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
